Dear Members:

Getting that first big funding grant is one of the most difficult challenges facing new researchers. Writing a successful grant submission is a skill that requires a good understanding of the funding environment, a solid proposal development strategy, and the ability to write proposals that are clear, polished, and compelling.

Canadian family medicine researchers now have an opportunity to further develop and hone their grant-writing skills, with a focus on the Canadian funding context, through participation in the Grant Generating Project (GGP) fellowship. The GGP, which was founded in 1995, is supported by the American Academy of Family Physicians (AAFP) Foundation; the North American Primary Care Research Group (NAPCRG); the Society of Teachers of Family Medicine (STFM); and now also the College of Family Physicians of Canada (CFPC). It is housed at the Virginia Commonwealth University in Richmond, Virginia.

The Section of Researchers' Council has been working with Dr. Daniel Longo, Director of the GGP, to include a focus on the Canadian research funding scene. The program will incorporate the Canadian focus beginning in 2012. To date, the GGP has helped junior- to mid-career trained researchers in the United States enhance their proposal development skills and has mentored them through the grant development process with remarkably high funding success rates.

It should be noted that **there is no fee** to participate in the GGP. However, there is a competitive process for admittance, and only a limited number of positions are available each year. Participants are responsible for their own travel and accommodations while they attend the in-person GGP sessions. As part of CFPC's support

for this important program, two training grants for the GGP are available for CFPC members through the Janus Research Grants Awards program to help partially off-set their travel and other expenses in association with their participation in the GGP program.

The Section of Researchers welcomes Dr. Alan Katz, new Council Chair

A warm welcome to Dr. Alan Katz, a long-time member of the Section of Researchers, who has recently assumed a 3-year position as the Section's Council Chair!

An Associate Professor and Research Director in the department of Family Medicine at the University of Manitoba, with a cross-appointment in the Department of Community Health Sciences, Dr. Katz is also the Associate Director for Research at the Manitoba Centre for Health Policy.

Dr. Katz plays an important leadership role in the Family Medicine Department at the University of Manitoba. In addition to teaching undergraduate students and supervising graduate students, he teaches family medicine residents in both clinical supervision and the fundamentals of research and scholarship, and mentors colleagues in the development of their research interest and skills.

Over the last ten years, Dr. Katz has built an impressive career in primary care research. Currently a principal or co-investigator on research projects with funding of over \$17 million, he is also the lead investigator on a 5-year CIHR New Emerging Team Grant focused on primary care oncology with an emphasis on colorectal cancer screening and follow-up care. His other research focuses on prevention, and health service provision and policy (including models of care and funding models) in primary care using administrative databases; quality of care indicators; knowledge translation; and disease prevention.

Dr. Katz also leads the Manitoba Primary Care Research Network (MaPCReN); a Manitoba regional network involved in the Canadian Primary Care Sentinel Surveillance Network (CPCSSN).

Dr. Katz has identified his main goals as follows: “This is a really exciting time to be a primary care research scientist in Canada. Over the next three years, I will endeavour to lead a vibrant section of active researchers that takes full advantage of new opportunities on the horizon. We look forward to family medicine research expanding both within the academic discipline and in community practices throughout Canada. The evidence generated through our research will improve the health of Canadians.”

“As I begin my work as the Chair of the Section of Researchers, I ask for your support in fulfilling this mandate during my term. I encourage you to contact me with your ideas, comments and views on the work of the section and its future directions. I know there are other ideas out there that would help us achieve our goals, so please send me your ideas!” he adds.

National Physician Survey (NPS) 2010 – Fast Fact: The 2010 NPS results are being highlighted in *Canadian Family Physician* with monthly [Fast Facts](#).

The January issue focuses on trends in the use of electronic medical records.

A comparison between the results of the 2007 and the 2010 National Physician Survey (NPS) shows that exclusive use of electronic medical records (EMRs) by family physicians, general physicians, and other specialists across Canada has increased from 10% to 16%. The most recent 2010 data showed that 39% of physicians used electronic records to enter and retrieve clinical patient notes.
